### **NEW BUSINESS:**

#### **Public Hearing regarding a request from 204 Hillcrest Group for approval of a PLCB license transfer.**

The purpose of the hearing is to receive public testimony regarding a request for transfer of License No. R-18795 from Lower Swatara Township, Dauphin County, to its restaurant facilities located at 204 Hillcrest Road, Hershey.

Jason Jean, 491 Middletown Road, Hummelstown – Mr. Jean and his wife currently operate Vigneto's Restaurant in the old Memmi's property. They are requesting the Board to consider the transfer of License No. R-18795 from a Middletown establishment to their current restaurant.

Supervisor Moyer asked if 204 Hillcrest Group has ownership interest in any other entities. Mr. Jean answered no.

Supervisor Ballard asked if Mr. Jean and his wife have ownership interest in other entities. Mr. Jean answered no.

Supervisor Fedeli asked what establishment the liquor license is coming from. Mrs. Jean said it would come from Tree House Grill LLC, in Middletown.

Chairman Abruzzo asked for the time at which there are no longer any patrons in the restaurant. Mr. Jean said 11:00 p.m. on Fridays and Saturdays. Sunday through Thursday, it would be 10:00 p.m. In the fall and winter, the hours would be one hour less. The restaurant is run as a BYOB type of an establishment.
