#### **NEW BUSINESS:**

## <u>Public Hearing regarding a petition to vacate Matlack Road as filed by Hershey Entertainment & Resorts Company.</u>

The purpose of the hearing is to receive public comment regarding the above mentioned petition.

**Charles W. Emerick, Director of Community Development** – Matlack Road is approximately .43 miles long spanning from Hershey Park Drive, at the entrance of Highmeadow Campground back to the common municipal boundary between Derry Township and Hummelstown Borough. The applicants have petitioned the Township to vacate this road because it provides access to lands owned by HE&R and is not used by

the general public. In the process of this vacation, two other reviews were done. One, Select Medical is proposing a traffic light at this intersection. Mr. Emerick spoke to their traffic consultant to verify this would have no impact on the traffic signal and all the facilities for that signal are within the PennDOT right of way outside of any Matlack Road right of way. The other review indicated Derry Township Municipal Authority (DTMA) has a land lock parcel in the campground that is not completely served by Matlack Road, but Matlack Road provides some entrance to the pump station. HE&R has agreed to work with DTMA to secure a clear access easement to that facility.

Vice-Chairman Fedeli asked why this was originally a Township Road. Mr. Emerick said there were 18 roads dedicated to the Township in 1988 in one dedication including Matlack. It was thought these were roads that we maintained anyway.

**PUBLIC COMMENT** – No one came forward.
