

Dear Parents:

Thank you for enrolling your child(ren) in the Township of Derry Department of Parks and Recreation Summer Day Camp program. Attached is the 2016 application for camp, which must be completed accurately and submitted with a \$45 per child non-refundable registration fee. Completed Child Health Appraisals can be turned in later, but must be on file prior to the start of camp. Upon receiving your completed application and registration fee, a confirmation letter will be emailed regarding your child's enrollment into the camp. Only Township residents will be enrolled prior to April 13. Afterward, enrollments will be accepted on a first-come, first-serve basis. Any delinquent accounts from previous years may not sign up for camp. Camp is limited to children entering kindergarten through sixth grade. Each classroom has a limit of 35 children (both full and part-time participants), except kindergarten, which is 15.

****Summer Day Camp Registration is now available online.****

Registration will be on April 6th, starting at 8:00 am. You can still register your child for Summer Day Camp at the Hershey Recreation Center. You can register your child online at our website, www.derrytownship.org under the Parks and Recreation Department link. We strongly encourage online registration. To register online you will need to have a login ID and PIN #, which can be obtained from the website, by entering an email address that is on file at the Recreation Center, or calling the Hershey Recreation Center (533-7138). **If you plan on using online registration, you must mail (605 Cocoa Ave., Hershey, PA 17033) or fax (717-533-2154) the application in by April 13th or one week after registration, otherwise the spot will be cancelled.**

Summer Day Camp will begin on June 13 and will end August 19.

Parents Night is scheduled for June 1, 2016 at the Hershey Recreation Center Room at 6:00 p.m. We strongly encourage you to attend, so you receive your child's camp T-shirts, packet of camp information and have an opportunity to meet with some of the counselors. **Please sign up for swim lessons during Summer Day Camp Registration.** Tuition will be accepted at Parents Night or at the Hershey Recreation Center during normal business hours. Remaining payments made by check will be accepted at Summer Day Camp. Please make a copy of the application as a reference for yourself.

You may only register members of your family. If you have any questions regarding the summer program, or if you require additional applications, please contact me at 533-7138.

AGREEMENT FOR SUMMER DAY CAMP
(Required by State Regulations)

Weekly tuition is due the Thursday preceding the week of service.

Please initial each line

_____ Full-time registrants will have one free week of vacation to use at their discretion. The vacation week **must** be taken Monday through Friday of the same week when your child does not attend.

_____ Deductions from the weekly fees for national holidays (July 4) are not permitted. The indicated weekly fee is required. We will be closed on July 4th.

_____ Any participant may be withdrawn prior to the end of camp with at least 2 weeks notice. If the appropriate notice is not given, you will be charged for 2 weeks of tuition.

_____ All payments for the reserved space are due the Thursday preceding the week the child is scheduled to attend the program. Tuition for the first week of camp is due by Thursday, June 9, 2016 and can be made at Parents Night on Wednesday, June 1st or at the Hershey Recreation Center during their normal operating hours.

_____ **Payments not made by Thursday evening, preceding the week that has been reserved will have a \$5.00/day (including weekends) late fee attached to the tuition payment. Names will be posted at Summer Day Camp to remind parents of the outstanding balance. Delinquent accounts of more than three business days (Wednesday of the following week) will constitute grounds for removal from the program indefinitely. Note: Payments can be made at the Recreation Center in the evening and on weekends or online.**

_____ Transportation to and from the Summer Day Camp Program will be provided by the parent or other designated person. Children must be signed in at the parent table, daily, by a guardian.

_____ Children exhibiting signs of illness (red or runny eyes, fever exceeding 100, vomiting, diarrhea, etc.) may not attend Summer Day Camp. If a child becomes ill while in our care, he/she will be isolated, and a parent or guardian will be notified and asked to pick the child up immediately. A charge of \$5.00 per 5 minutes will occur when the child is not pick-up within an hour.

_____ Medical care will be paid by parents or their insurance company. **Insurance #** _____

_____ A current health appraisal must be on file prior to participation in the camp.

_____ Township of Derry will provide supervision, recreation, swimming, snacks, pizza, ice cream and bused field trips on specific days. The stated scheduled activities are subject to change, due to child care and lifeguard staffing ratios, and weather. All efforts will be made to accommodate the published schedule.
