A. Review and recommendation of a proposed ordinance amending Chapter 225 (Zoning) of the Code of the Township of Derry regarding Article XXIX (Design Review Board; Chocolate Avenue Preservation Overlay District) and Article XXXIV (General Regulations), Section 225-171 (Fences)

Mr. Emerick reported that the proposed amendments are as follows:

Inclusion of a member of the Hershey-Derry Township Historical Society to serve on the Design Review Board, adjustment to the terms of membership to ensure no more than two terms expire in any year, note that a Certificate of Appropriateness is only approved by a majority vote, and inclusion of a revision to the guidelines for signs and awnings to encourage dimensional signs.

Due to the prevalence of modular pre-fabricated fencing, adjustment to the Township regulations is necessary to reduce the amount of variances requested. The proposed ordinance limits the maximum panel of a fence to be 72 inches in height, allowing 4 inches of clearance from the ground to the bottom of the fence and decorative finials no more than 10 inches above the fence.

Ms. Myers-Krug stated that since the Design Review Board will have an even number of members, tie votes are automatically denied. Ms. Myers-Krug suggested discussing a contingency to those denied applications.

MOTION

On a motion made by Member Mangione, seconded by Secretary Wehler, and a unanimous vote, the Planning Commission recommended that the ordinance be adopted.
