RESOLUTION NO. 1456

A RESOLUTION OF THE TOWNSHIP OF DERRY, DAUPHIN COUNTY,
PENNSYLVANIA, REVISING THE FEE SCHEDULE ESTABLISHED IN RESOLUTION NO.
1378 REGARDING REIMBURSABLE FEES FOR SERVICES PROVIDED BY THE
TOWNSHIP ENGINEER UNDER CHAPTER 185 (SUBDIVISION AND LAND
DEVELOPMENT) AND CHAPTER 174 (STORMWATER MANAGEMENT) OF THE CODE
OF THE TOWNSHIP OF DERRY

WHEREAS, Chapter 185, Article III, Section 185-14 of the Code of the Township of Derry establishes the obligation of applicants of subdivision and land development plans to reimburse the Township for costs that the Township has incurred in having such plans and supporting data reviewed by the Township Engineer and/or professional consultants, and;

WHEREAS, Chapter 185, Article X, Section 185-55.A. of the Code of the Township of Derry establishes the obligation of the applicants of subdivision and land development plans to reimburse the Township for costs that the Township has incurred in having improvements required by such subdivision and land development plans inspected by the Township Engineer and/or professional consultants, and;

WHEREAS, Chapter 185, Article X, Section 185-55.A. of the Code of the Township of Derry requires that fees for reimbursement shall be established by resolution, and;

WHEREAS, Chapter 174, Article XIV, Section 174-42.B. of the Code of the Township of Derry establishes the obligation of applicants of stormwater management plans to reimburse the Township for costs that the Township has incurred in having such plans and supporting data reviewed by the Township Engineer, Township Solicitor, and/or professional consultants, and;

WHEREAS, Chapter 174, Article XIV, Section 174-43 of the Code of the Township of Derry establishes the obligation of applicants subject to the provisions of Chapter 174 to reimburse the Township for costs that the Township has incurred in activities associated with the approval, installation, inspection, and/or enforcement of the provisions of Chapter 174 by the Township, Township Engineer, and/or professional consultants, and;

WHEREAS, Chapter 174, Article XIV, Section 174-42.A. of the Code of the Township of Derry requires that fees for reimbursement shall be established by resolution, and;

WHEREAS, the Township of Derry now desires to revise the fees to reflect actual current costs incurred by the Township in reviewing said plans and inspecting said improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the Township of Derry that the following reimbursement fees are hereby established for plan review work and for improvement inspection work as follows:

Staff Professional I	\$125.00

Senior Professional	\$170.00
Principal	\$180.00

Professionals include Engineers, Land Surveyors, Landscape Architects, Planners, Geologists, Scientists and similar professionals.

Technicians include Designers, CADD Operators, Inspectors, Survey Technicians and similar technical staff.

Reimbursable expenses are billed at cost plus 10%, including, but not limited to travel, printing, postage, photography, videos, laboratory work, equipment rental, and special outside consultants.

This resolution shall supersede Resolution No. 1378, and any conflicting resolution or ordinance, effective as of January 1, 2016.
