BUILDING & ZONING PERMITS:

- New or revised submissions. Until further notice, we are only accepting submissions that
 are submitted digitally, with the application and required number of the supporting
 plans and documentation being mailed to the Community Development office at 600
 Clearwater Road, Hershey, PA, 17033. Contact Michele Pecho at
 mdpecho@derrytownship.org for number of copies and fees to be included with the
 mailing.
- <u>Permit issuance</u>. We are NOT issuing permits until further notice, except for health care facilities, emergency repairs, or if the contractor has received an exemption from the State (DCED) that allows them to continue to work. If an exemption has been issued, it must be e-mailed to the Township at commdevinfo@derrytownship.org <u>PRIOR</u> to the permit being issued.
- <u>Inspections</u>. The Township will only conduct inspections for health care facilities, emergency repairs, or if the contractor requesting the inspection has received an exemption from the State (DCED) that allows them to continue to work. If an exemption has been issued, it must be e-mailed to the Township at commdevinfo@derrytownship.org PRIOR to requesting an inspection.
- Also of note, DCED has established a deadline of Friday, April 3rd at 5:00 p.m. for the submission of waiver requests.
