INTRODUCTION:

Vice Chairwoman Nutt stated this is a Public Hearing regarding a request from Hidden Still, Inc., for the approval of an intermunicipal transfer of Liquor License No. R-16386 from the City of Harrisburg to 505 Rear West Chocolate Avenue, Hershey, Derry Township. She turned the meeting over to Solicitor Armstrong. He stated this Hearing has been advertised and is now open. He noted the purpose of this Hearing is to listen to the request to move a liquor license into the Township.

Mr. Jack Raudenbush, Hidden Still, stated they have a R-liquor license and explained how this license works. They are seeking to transfer this license to their establishment so they can offer a broader range of alcohol. He spoke about their hours and that they close by 11 p.m. They have no plans to be open past 11 p.m. with the new license. Vice Chairwoman asked about RAMP for checking ID. He stated they are already setup with this certification.

Vice Chairwoman Nutt made a motion to adopt Resolution No. 2023-09 to approve the transfer of restaurant Liquor License No. R-16386 into the Township of Derry. Supervisor Zmuda seconded the motion. **Motion carried 4-0.**
