### **INTRODUCTION:**

Chairman Abruzzo stated this is the reconvened public hearing regarding Conditional Use Application No. 2022-06 (Plat 1359), as filed by equitable owner Linlo Governor Crossing, LLC and Sheetz, Inc., regarding a Master Plan Development. He asked that everyone identify themselves when they speak at the podium. He noted that some people in attendance tonight may be under the impression that the extension of Hope Road will impact Hershey KinderCare. He provided copies to the Board. During Attorney Crist's questioning, Attorney MacNair objected to questioning who could be sued. Solicitor

Nelson upheld his objection. Attorney Crist continued to ask Mr. Stump questions and finished his questions.

Solicitor Nelson stated the next hearing would be May 31.
