# DERRY TOWNSHIP DOWNTOWN CORE DESIGN BOARD MEETING MINUTES April 24, 2023

## A. Consideration of generator at 64 West Chocolate Avenue (Hurst Electric, LLC, on behalf of First United Methodist Church; DCDB 481)

John Brown, a representative with GenServe, Inc., explained that they are the generator company that is supplying the equipment for the project. GenServe, Inc. hired Hurst Electric, LLC to do the permitting and electrical install. The project involves the removal of an old 7 KW generator from the basement and the installation of a 20 KW diesel unit on a concrete pad in the courtyard.

David Habig stated that the only concern Township staff has with the proposal is that the generator is properly exhausted, and that will be looked at during the building code review.

Mr. Brown noted that per code, the generator has to be located at least five feet from the building, and it is being placed approximately 20 feet from the building. There should not be any exhaust that can get into the building.

Member Raudenbush commented that because the generator will be in the courtyard, it will be adequately screened from view from West Chocolate Avenue.
