# **NEW BUSINESS**

# Public hearing regarding a request from Loto Station, LLC, for the approval of an intermunicipal transfer of Liquor License No. R-11866 from the City of Harrisburg to 1219 West End Avenue, Hummelstown, Derry Township

Chairman Abruzzo introduced the hearing. Attorney Gregory Szallar, Flaherty & O'Hara, representing Loto Station introduced their petition. He stated Loto Station is located on West End Avenue in Hummelstown. They are a brewery and full service station restaurant. He spoke about their current license and their request to transfer liquor license No R-11866 from the City of Harrisburg. He spoke about the employees, security cameras for the facility, upcoming events and hours of operation at the establishment. He outlined their responsible alcohol management including having RAMP training and instituting a 100% carding policy for their events and for anyone who looks under 35 for the restaurant. He spoke of the requirement for a municipality to approve the

transfer of the license and asked the Board to approve the transfer. He noted that the meeting was properly advertised.

The Board had no questions for the applicant.

Supervisor Zmuda made a motion to approve the request of Loto Station, LLC to transfer restaurant liquor license no. R-11866 into Derry Township and approve and adopt the attached Resolution No. 2023-24, specifically approving the liquor license transfer (or a revised version thereof). Supervisor Corado seconded the motion. **carried 5-0**.
